PROGRAM OVERVIEW

The program will target medical, nursing, and allied health professionals, chaplains, social workers, and students, especially those outside the palliative care specialty, with a shared interest in relieving suffering and providing compassionate care and recognizing the diverse needs of individuals and families at the end of life.

LEARNING OBJECTIVES

Following this symposium, participants will be better able to:

- Describe best practices for effective communication with patients and families facing life-limiting illnesses, with a special focus on assessing for status of written Advance Directives (AD), initiating conversations in a variety of settings, reframing patient/family goals, and managing one's personal discomfort during difficult conversations.
- Compare sample (video case) conversations to identify features and strategies associated with positive patient and family interactions and recognize potential pitfalls.
- Practice interview skills and communication techniques in role-playing activities to facilitate advance care planning (ACP) conversations.
- Apply strategies for motivating and guiding patients and families to develop actionable advance care plans that are consistent with their goals for care.

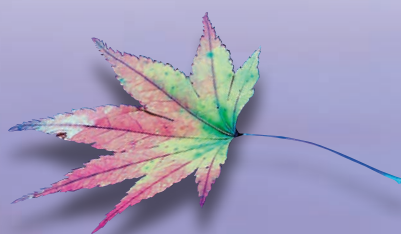

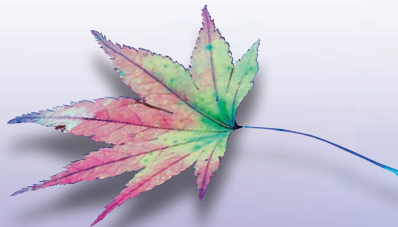
