

PROGRAM DESCRIPTION

The care of cardiovascular disease is rapidly evolving to include multiple members of the heart team including interventional cardiologists, cardiac surgeons, imaging specialists, cardiac ICU teams, and cardiac anesthesiologists. This conference will focus on heart team approaches to adult and pediatric cardiac diseases as well as ECMO and Heart failure/ LVAD therapies. The symposium will address knowledge gaps and the benefits and limitations of novel and traditional approaches to cardiovascular diseases.

EDUCATIONAL OBJECTIVES

Through participation in this conference, the participants will have an opportunity to:

- To apply the most up to date and effective treatment options for patients with various cardiovascular diseases
- To determine appropriate mechanical circulatory support for heart failure patients.
- To assess complex pathophysiology of single ventricle patients and select the appropriate palliative therapy.
- To apply the most up-to-date ACC guidelines for treatment of valvular diseases.
- To determine the benefits and limitations of trans catheter valve repair and replacement including ideal patients.
- To apply the current state of surgical outcomes for conventional and minimally invasive valve surgery and coronary artery bypass grafting.
- To analyze new medical and hybrid treatments for atrial fibrillation and ventricular tachycardia.
- To understand treatment options for complex aortic desease
- To create a management plan to provide coordinated care and a consistent message between providers throughout the entire care of the cardiac patient.
- To define ethical issues surrounding patients with cardiovascular disease.
- Identify appropriate patient selection and care of ECMO patients.
